Skate Park Release and Indemnity Form

Portable structures provide individuals with the opportunity to engage their skills and interests in a highly skilled and specialized activity. These structures allow the individual to perform tricks, as a result participants and parents/guardians must be aware of and accept responsibility for the associated risks. This form represents a release of liability and an agreement between the YMCA of Oakville and the participants and their parents/guardians. Participants must read and sign this form prior to accessing the skate park.

In consideration of being allowed to participate in any way on the YMCA Skate Park, the undersigned acknowledges, appreciates and agrees that:

- 1. The risk of injury from the activities involved in this program is considerable, including the potential for permanent paralysis and death. The inclusion specific rules, equipment and personal discipline help reduce the risk and the skater agrees to abide by them.
- 2. **I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my participation**
- 3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
- 4. I _____ hereby release and hold harmless the YMCA, their employees, other participants or sponsors with respect to any and all injury, loss or damage of person or property, whether caused by the negligence of the releases or otherwise.
- 5. The staff person on duty has explained rules, risks and dangers of using the skate park, in return, I _____ agree to obey all rules and regulations of the YMCA of Oakville Portable Skate Park
- 6. I am aware that the activity in which I am about to participate in is dangerous and the possibility of injury exists
- 7. I declare my intention to participate in these activities at my own risk, and I specifically release the YMCA and staff from any responsibility regarding any loss or damages that may occur
- 8. I will follow and comply with each and all instructions given by any of the YMCA employees
- 9. I accept responsibility for any expenses incurred on my behalf or as a result of my action
- 10. **I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGNING IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT**

I _____ have read and understood this release and indemnity form and agree to assume all the risks of personal injuries to me (or my child). I hereby waive all liability claims against the YMCA of Oakville Portable Skate Park, its owners and employees for any injuries, ailments or other damages my child may incur while attending the YMCA of Oakville Portable Skate Park.
